Course Overview;

An Overview

This session aims to provide an understanding of safety along, with an exploration of the legislation that supports it.

Safety Planning

Participants will delve into the fundamentals of safety planning covering the four components necessary for creating a safe work environment.

Types of Hazards

During this session we will discuss common workplace hazards that need to be identified and addressed in order to prevent injuries and ensure employee well being.

Managers Role

In this session participants will gain insights into the role and responsibilities that managers hold in promoting and enforcing safety standards within their organizations.

Training

The importance of training in enhancing safety will be emphasized during this session. We will also touch upon training preparations to ensure optimal learning outcomes.

Stress Management

Participants will have the chance to explore stress management techniques. This includes strategies such as making alterations avoiding stressors when possible accepting situations practicing relaxation methods well as incorporating routine based approaches.

Workplace Violence

This particular session focuses on defining workplace violence and addressing how it can be effectively managed. Furthermore we'll discuss implementing a workplace harassment policy to foster a working environment for all employees.

Identifying Your Company Hazards

Participants will learn how to identify hazards unique to their organization. The emphasis is placed on prioritizing deficiencies found during inspections, as reporting and following up on these findings accordingly.

Alcohol Abuse

This session aims to educate participants, on the impact of drug and alcohol abuse well as identify individuals who can contribute to maintaining a workplace that is free, from substance misuse.

Developing the Safety Plan

Once workplace hazards have been identified participants will be guided on how to create a safety plan and understand which individuals should be involved

Plan Implementation

Participants will focus on implementing the safety plan by outlining the roles and responsibilities of those involved.
